The Bidder proposes and agrees, if this Bid is accepted, to contract with the City of Rome, Georgia, in the form of contract specified, to furnish all necessary products, machinery, tools, apparatus, means of transportation and labor necessary to complete the construction of **EAST ROME – EAST 12TH SIDEWALK IMPROVEMENTS – PHASE 1, Bid No. 023-17**, in full and complete accordance with the noted, and reasonably intended requirements of the Specifications and Contract Documents to the full and entire satisfaction of the City with a definite understanding that no money will be allowed for extra work except as set forth in the attached General Conditions and Contract Documents, for the following prices:

Contract "C" shall consist of the removal and replacement of existing concrete curb and gutter, sidewalks and drives (including drive aprons, drive along Cedar between East 12th Street, SW, and East 13th Street, SW, will be replaced with 30-inch curb and gutter and 5-ft. concrete sidewalk abutting said curb, no drive(s) to be replaced) along the east side of Cedar Avenue, SW, beginning at the radius return on Cedar Avenue at the intersection of Maple Street, SW, and Cedar Avenue, SW, in a southerly direction along the east side of Cedar Avenue, SW to the intersection of Cedar Avenue, SW, and East 13th Street, SW, as well as the said intersection. All concrete curb and gutter installed shall be adjusted from its current elevation to match the existing pavement. This contract shall also include drainage improvements at the intersection of Cedar Avenue, SW, and East 13th Street, SW.
