VICTIMS BILL OF RIGHTS

You have the right to be notified of;

- The arrest and release of the accused,
- The availability of victim service programs,
- The availability of compensation for victims of violent crimes,
- Court proceedings during prosecution of the case,
- The right to be heard at any scheduled court proceedings involving the release, plea, or sentencing of the accused,
- The right to restitution as provided by law,
- Motions for new trial,

You have the right to;

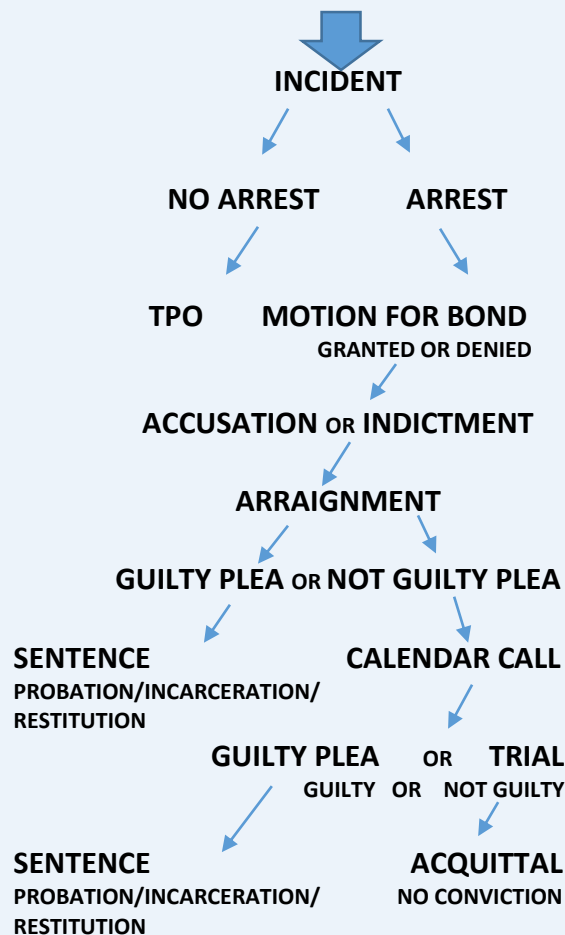
- Express your opinion regarding the release of the accused pending the disposition of the case,
- Express your views concerning the outcome of the case.
- Complete a Victim Impact Statement.

PLEASE BE AWARE:

As the victim of a crime, you have the right to refuse or agree to be interviewed by the accused, the accused's attorney, or anyone who represents or contacts you on behalf of the accused in the case. If you agree to be interviewed, you may set conditions for the interview, who may be present, any security arrangements for the interview and whether or not the interview may be recorded. You also have the right to terminate the interview at any time or to refuse to answer any questions during the interview. If you have questions, you may contact the District Attorney's Office at 706-291-5210.
